CERTIFICATE OF INCORPORATION

OF

THREE FOUNTAINS COPPORATION

KNOW ALL MEN BY THESE PRESENTS: That we, Brank Colff Link B. Recking and Bachara A. Bannet . citizens of the United States, and residing in the State of Colorado, have associated ourselves for the purpose of forming a body corporate and politic, not for pecuniary profit, under the provisions of the general laws of the State of Colorado, and particularly Article 19, Chapter 31, 1963 Colorado Revised Statutes, and amendments thereto, and we hereby make, execute and acknowledge this certificate of our intentions so to become a body corporate and politic, under and by virtue of said statute.

ARTICLE I

The name of this Corporation shall be "Three Fountains Corporat;

ARTICLE II

The term of existence of this corporation is perpetual.

ARTICLE III

The object and purpose of the corporation is to administer, and govern, on a non-profit basis, that certain condominium real property located in the City and County of Denver which has been here-tofore submitted to the provisions of the Condominium Ownership Act of the State of Colorado by the recording of a declaration entitled "Condominium Declaration For Three Fountains, Filing No. 1". A further object and purpose of the corporation is to administer, manage and govern, on a non-profit basis, separate adjoining real property which may, but need not be, submitted to condominium ownership, with the provision that this corporation shall administer and govern the same. The object and purpose of this corporation shall be deemed to include the operation and maintenance of a public vater supply system and the operation and maintenance of a public sanitary sewer system within the boundaries of the condominium property above described.

ARTICLE IV

This corporation is one which does not contemplate pecuniary gain or profit to the members thereof and is organized for non-profit purposes. This corporation does not afford pecuniary gain to its members incidentally or otherwise, but members may be paid for services actually rendered to the corporation. This corporation has no power to carry on propaganda, attempt to influence legislation or take part in a political campaign.

ARTICLE V

The officers of the corporation, their term of office and the manner of their designation and selection; the qualifications for membership in said corporation; the voting and other rights and privileges of members and the liabilities of the members for assessments shall be set forth in the By-Laws.

ARTICLE VI

The persons who shall be authorized to execute all instruments of conveyance or encumbrances, including promissory notes, shall be the President and Secretary. The persons who shall be authorized to execute and deliver, as attorney in fact for any member, any contrac deed or other instrument with respect to the interest of a member. (condominium unit owner) for such purposes as are provided in the Condominium Declaration for Three Fountains, Filing No. 1 (and subsequent condominium Declarations as provided at Article III and in the By-Laws), shall be the President and the Secretary.

ARTICLE VII

The affairs and management of the corporation shall be under the control of a Board of Managers. The initial Board of Managers shall be composed of the following three persons who shall manage the affairs and concerns of the corporation for the first five years of its existence or until their successors are appointed or elected and qualified as provided by the By-Laws:

ARTICLE VIII

The principal office of said corporation shall be located at 1777 South Bellaire Street, Denver, Colorado, and the Registered Agent shall be Brad Wolff, whose address is the same.

ARTICLE IX

The managers shall have power to make such prudential By-Laws as they may deem proper for the management of the affairs of this corporation, not inconsistent with applicable laws and regulations and not inconsistent with the Condominium Declaration for Three Fountains, Filing No. 1., and subsequent condominium Declarations committed to this Association.
